Engineering measures : Minimize workplace exposure concentrations.

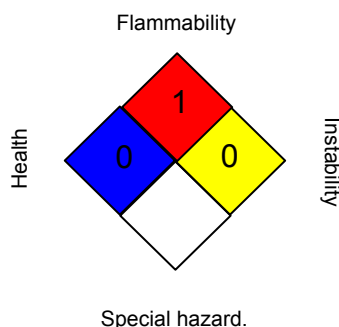
